



Notice Inviting Bid

Sealed bids are invited from **reputed, experienced, and licensed pest control agencies** for providing **comprehensive pest control services** (Rodent, Cockroach, & other Insects Control) at the **Bank Head Office and its 24 Branches** as per the provisions of **RTPP Act, 2012 and Rule, 2013**.

1. Scope of Work

The successful bidder shall provide comprehensive pest control services at Bank Head Office and its 24 Branches as per detail enclosed at Annexure-I including :-

- Rodent Control
- Cockroach Control
- Ants & Other Crawling/Flying insects Control

Areas Covered :- The pest control should cover all the places in Bank Hall/rooms/Cabins like spray under the tables, chairs, Almirahs, on and around the pile of files, on wooden furniture, on false ceiling, on all staircases, on lift lobby, on all toilets drain ducts, on all pantry rooms, in all stores and any; hidden space under the furniture and should leave no space unattended.

2. Frequency of Services

3. Contract Period

Initial contract period shall be two (2) years. . However, the contract may be extended for a further period of one year on mutual consent & satisfactory performance.

4. Eligibility Criteria

- a) Registered Pest Control Operator with valid license.
- b) Minimum 03 years experience in similar work.
- c) GST Registration.
- d) PAN Card.
- e) Use of approved, eco-friendly & WHO/ISI compliant chemicals.

5. Submission of Tenders:

- i. The technical bid including EMD and financial bids must be submitted in two separate sealed cover subscribed as Technical Bid and Financial Bid in the format as prescribed in Annexure-II and Annexure-III respectively.
- ii. Both the technical bid and financial bids are to be kept in a big separate sealed envelope.
- iii. The big envelope containing the two envelopes must be superscribed "Tender for Pest and Spray Management Services".
- iv. The sealed bid must be submitted in the office of The Jaipur Central Cooperative Bank Ltd., F-1, Nursery Circle, Vaishali Nagar, Jaipur HO by Hrs. of2026.
- v. Technical bids shall be opened on at Hrs. in the presence of authorized representatives of bidders.
- vi. Late/delayed tenders due to any reason, whatsoever will not be accepted/ considered, at all, under any circumstances.
- vii. Bidders are advised to visit the place of work (As per Annexure-I)for assuring the nature and volume of work realistically before quoting the rates.
- viii. The quoted rates should include the cost of pesticides and related labour and transportation charges. The chemicals/pesticides used by the agency be purchased from reputed concern and should be ISI Marked and/or WHO approved.
- ix. The rates should be mentioned in figures as well as in words inclusive of all taxes.
- x. Selection of successful bidder will be on the base of L1, bidder may all successful technical bidder total cost of all items will be considered for financial Bid evaluation.

6. Performance Security:

- a. The successful bidder shall be required to deposit an amount equal to 5% of the contract value within 15 days of issue of letter of intent, as Performance Security.
- b. Performance security shall be submitted in the form of Demand draft drawn in favour of " The Jaipur Central Cooperative Bank Ltd." payable at Jaipur and shall be valid for a period of

beyond two months of expiry of contract period.

- c. Performance security will be discharged after completion of contractor's performance obligations including warranty obligations under the contract, without any interest.
- d. If the contractor fails or neglects any of his obligations under the contract. The Jaipur Central Cooperative Bank Ltd. reserves the right to forfeit either whole or any part of Performance security furnished by the bidder as penalty for such failure.

7. Payment Terms

- Payment to the successful bidder shall be released on Quarterly basis on submission of Service Report for the services rendered in the particular quarter.
- TDS and any other Government levies applicable shall be deducted on bill amount as per Government of India rules issued from time to time.

8. Terms & Conditions

1. Chemical used shall be safe for humans and office equipments.
2. The bidder shall be responsible for any damage caused during service.
3. Sub-letting is not permitted.
4. The Procuring Entity reserves the right to accept or reject any or all bids under RTPP Rules, 2013.
5. The Procuring Entity may terminate the contract any time during the currency of the Contract without assigning any reason in case of
 - Unsatisfactory Performance
 - Breach of terms
 - Misrepresentation of facts
6. All disputes shall be governed as per RTPP Act, 2012 & Rules, 2013 and jurisdiction shall be Jaipur (Rajasthan)


